- ❖ Have your child give you a "mini lesson" to show you what they have been learning
- ❖ Listen to different types of music (jazz, classical, etc.) together and discuss what you both like
- ❖ Take lessons or practice yourself!

Financial Responsibility Agreement

By signing this agreement, you acknowledge your financial responsibilities to Prairie Lane Studios. You are acknowledging that you have read, understand and agree to the tuition portion of the studio handbook, including missed lessons and attendance policies.

- Tuition is due the first day of each month. On time payments are appreciated. A \$5.00 late fee will be added to payments received after the 10th of each month.
- Students will not be able to participate in lessons or studio events if tuition has not been paid.

During the summer session, students will be able to pay on a week to week basis due to possible conflicts such as camps, vacations, etc. Payment will be due at the time of the lesson, no exceptions – cost is \$20 per lesson (cash or check made payable to Prairie Lane Studios or Tracy Smith). Students can also pay on a monthly basis, however, no carryovers if a lesson is missed.

Staff reserves the right to discontinue lessons/ensembles with a student for poor attendance for lessons/performances, not being prepared for lessons/ensembles, late payments, poor attitude or disrespect towards instructor or others at Prairie Lane Studios.

Your tuition includes:

- ❖ Teacher experience and training
- ❖ Continuing education
- ❖ Studio scheduling, planning, communications and administration duties
- ❖ Instrument maintenance (piano)
- ❖ Planning and expenses for performances/recitals
- ❖ Office supplies, computer equipment/software
- ❖ Taxes, insurance, utilities

Tuition does not include weekly materials (lesson books, assignment notebook), ensemble fees or instrument rental

Attendance Policy

Tuition includes all scheduled activities, regardless of attendance and reserves your time in the studio. There are times when you may need to “trade” lesson times with someone if you are unable to make your own lesson time due to illness, sports, vacations, etc. I am not able to reschedule every missed lesson. Everyone will use the “trade” list at some point. Please extend courtesy when asked to trade a lesson time – common courtesy! Don’t run the risk of forfeiting a lesson – TRADE!

Lessons cancelled by the instructor will be rescheduled.
